Please make sure you have read the following RULES & REGULATIONS (Keep this page!)

- **NO VEHICLE OVER 13’ HIGH WILL BE ALLOWED TO PARTICIPATE DUE TO THE OVERHEAD SIDEWALKS**
- **There is to be NO THROWING CANDY!**
- There is to be NO LIVE SANTA’S on any float or in any vehicle. THE ONLY SANTA in the parade will be riding on the fire truck at the end of the parade. Santa hats ONLY are allowed. The GRINCH may wear a Santa hat and/or jacket.
- NO SIRENS are allowed once your unit reaches the overhead sidewalks.
- NO ALCOHOLIC BEVERAGES in the line-up area or parade.
- ALL UNITS TO BE JUDGED must be lined up by 5:30 p.m. If you are not being judged, please be in place by 6:00 p.m.
- ONLY REGISTERED UNITS with their # placard in view will be allowed in the line-up area. DROP-OFF area for participants will be the First Presbyterian Church NORTH parking lot. Please use the W. First North St. entrance to enter and exit. **You may not use W. Main St. to drop off participants.**
- All units should use parking lights only during the parade. DO NOT use headlights.
- **All vehicles participating in the parade MUST provide proof of liability insurance. A certificate of insurance and copy of the driver’s license of the person driving the vehicle MUST be turned in no later than Monday, November 25.**
- A representative of each entry MUST attend a **MANDATORY** participant drop-in to be held on **Monday, December 2** anytime between 5:30 – 7:30 p.m. at the Chamber (825 W. 1st North St). If no representative of your unit attends this meeting, YOU WILL NOT BE ALLOWED TO PARTICIPATE IN THE CHRISTMAS PARADE. Line up numbers will be distributed at this meeting. This number should be communicated to EVERYONE in your unit. Also, you should inform everyone in your group of the parade rules.

ABOUT YOUR ENTRY: Please check at least one of the choices on the following page. **ONLY ONE VEHICLE PER GROUP OR ORGANIZATION IS ALLOWED.** Marching/walking groups may also enter one vehicle. A trailer being pulled by a truck is considered one vehicle.

All vehicles must be decorated for Christmas. NO REFUNDS will be given to units canceling.
